## **Reports from Committees**

**Evangelism**: Presented by Dawn Deines-Christensen

Congregational potluck scheduled for 02/23/2020 speaker will be Krista Vanden Brink. Committee plans to re-evaluate potluck to increase attendance and family outreach. Report on food packing event for local and international mission held on 2/1/20 was a success. Approximately 50 volunteers between church members, nonmembers and members of local rotary Club were present and accomplished the full project in less than 3 hours. Committee plans to work on effort to get our church local out more visually including welcome signs and cards in the pews. They are working on audio visual work including Facebook, brochures and magnets. Visitor bags have been made in are available for to those visiting the church with information about us.

## Worship: Presented by Matt Burkey

Committee discussed current supply pastor schedule and possible transition for a new incoming pastor. Jeff Rodman presented opportunity for youth to lead services on 3/29 and plans to coordinate with the currently scheduled supply pastor Daryl Thompson. Looking to continue with liturgy assistance and coordinate now and with a new pastor in the future. Discussed plans to hold a breakfast in the fall. Committee member Gregg Pattison is stepping down and therefore committee will need to find a replacement for a council member. April 1<sup>st</sup> Lent soup supper, plan to coordinate chili cook off. Looking for 7-8 participants. Committee discussed the present need for liturgy assistants and how it is helpful our congregation is more involved. We felt that if our new pastor would still want this type of help, committee would continue to find liturgy assistants.

Stewardship: Presented by Julie Askelson

Plans to replace tables in social hall underway and financially will be supported by a Depot grant, Virginia Sacquitne Endowment, money from Nordic Fest dinner and the women's and men's group therefore we will not need to do a capital campaign. During council meeting it was discussed to consider donating the old tables. So now moving on to possibly replacing the old rectangle tables in the social hall and used for other church activities, currently stored under the stage. At this point taking inventory and looking into options. Plans for Aase Haugen and their new structure, stewardship is looking into possibly furnishing their new

chapel-currently gathering information as the building has been delayed. Lent offerings will go toward Aase Haugen.

**Education**: Presented by Jeremy Thompson

Spent committee meeting time welcoming new members and getting them on board. Discussed current Sunday school attendance numbers. Kathy Elsbernd will lead the 7-8<sup>th</sup> graders in the 40 days in the Word during lent. Brigit Storhoff will do the same with the high school youth. Sugar Creek VBS is contracted for 7/20-7/23. Committee is working holding VBS option for the younger kids not included in Sugar Creek and Jeff Rodman to do something with 7<sup>th</sup> graders and the nursing homes possibly. High school graduating seniors to get traditional mugs, expecting about 22 students. Committee also looking into a teacher appreciation coffee event.

**Property Management**: Presented by Tamie Onsager

Reviewed rentals: SoDa club and associated piano lessons. Committee agreed to meet with Jill Wilson to discuss use and possible associated fees. Request submitted by Shirley Finley to consider compensation to Julie Askelson for typing up a human resources binder for the church. Committee agreed to this consideration. Committee plans to have an attorney review the Human resources binder. Committee also plans to review and update policies regarding church rental charges and visitation fees. Still working on replacing the hearing aids.

Committee agreed to work on getting purchase requisitions standardized and more detailed in order to better account for which accounts are used and for what purchases. Actively seeking quotes for education wing roof. They've received one quote so far. Continuing to assess and work on handicap access within the church. Insurance for the church is due for review in October, it has been some time since assets and coverage has been reviewed and clarified. Currently seeking estimates to update and replace current sound system. Plan to work on touch up painting throughout the church and seeking volunteers.

Youth: Presented by Andrea Wilson

Due to previously scheduled youth event monthly meeting was rescheduled to 4/16/20 so not much new to report. Since the last council meeting Jeff Rodman's 60 day review was completed and submitted to the office. Currently looking to plan for Easter sunrise service, Easter breakfast and summer youth trip.

Human resources manual completed and ready for review by an attorney.
